This SMS Privacy Policy explains how we collect, use, store, and protect your information when you opt in to receive text messages from us. Information We Collect

When you sign up for our text messaging program, we may collect:

- Your mobile phone number
- Your name, Name of Business (if provided)
- Any other information you voluntarily share via text (e.g., responses to messages)

We may also collect data about your interactions with our messages, such as delivery status or responses, to improve our services.

How We Collect Your Information

We collect your information when you:

- Opt in to receive texts (e.g., by texting a keyword like “JOIN” to our number, filling out a form, or verbally agreeing with a clear disclosure)
- Reply to our messages or engage with our SMS program

Participation is voluntary, and you can opt out at any time (see below).

How We Use Your Information

We use your information to:

- Send you updates, promotions, alerts, or other messages you’ve agreed to receive

How We Protect Your Information

We take reasonable steps to safeguard your data, including:

- Using secure systems and trusted service providers to send messages
- Limiting access to your information to authorized personnel only
- Storing your data only as long as needed for the purposes described or as required by law

Sharing Your Information

We do not share your phone number or SMS opt-in consent with third parties for their own marketing purposes. We may share your information with:

- Service providers who help us deliver texts (e.g., our SMS platform), bound by confidentiality agreements
- Legal authorities, if required by law or to protect our rights

Your opt-in data and consent status remain exclusive to you and you and your business and are not sold or shared beyond what’s needed to provide this service.

Your Rights and Choices

- **Opt-Out:** You can stop receiving texts at any time by replying “STOP” to any message. We’ll process your request promptly, though it may take up to 24 hrs. to fully take effect.
